Commentary on statistical overview of developments in the Court's caseload in 2007

Number of applications

In 2007 the number of applications allocated to a decision body increased by 6 % overall as compared with 2006. While the increase in number of applications allocated to a Committee was only 1 %, the increase in applications allocated to a Chamber rose by 35 %.

Pending cases

The number of cases pending before a decision body increased by 19 % in 2007. The number of applications disposed of judicially in 2007 remained lower than the number of applications allocated to a decision body. The annual deficit was more than 13,000 applications (i.e. a monthly deficit of more than 1,080 applications) which is a 33 % increase as compared with 2006.

Processing applications

The number of applications pending at the pre-judicial stage rose by 4 % in 2007. The number of applications disposed of administratively increased by 9 %. These are applications that were incomplete because the applicants failed to submit the application form duly completed together with the necessary documents within the allotted time.

In 2007 the number of applications declared inadmissible or struck out of the list of cases by a Committee or a Chamber fell by 4 %. The number of applications disposed of by a final judgment¹ increased by 16 %. The number of applications in respect of which a judgment was delivered remained stable (+1 %), although the number of judgments delivered fell by 4%. In other words, slightly more applications were decided with fewer judgments delivered, indicating that, in an effort to enhance efficiency, a greater number of applications are being joined. The number of cases communicated to a respondent Government increased by 7 %.

These figures can be explained in part by the Court's policy of concentrating efforts on Chamber cases and backlog cases. However, the applications processed by a Committee represent 89 % of the total number of applications disposed of at the judicial stage.

In 2007 the number of judgments of low importance, in which the Court merely repeated its established case-law, fell by 7 % while the overall number of judgments contributing to the case-law (whether of medium or high importance) rose by 8 %.

Requests for interim measures (Rule 39 of the Rules of Court)

As compared with the previous year, the number of requests for interim measures increased significantly in 2007 in particular in respect of two countries: France and the United Kingdom. The Court granted requests for interim measures in 262 cases (i.e. an increase of 404 % as compared with 2006) and dismissed them in 565 cases (54 % more than in 2006). In addition, many requests fell outside the scope of application of Rule 39 of the Rules of Court

but nonetheless required an urgent examination and thus diverted resources from the processing of cases.

Backlog applications

As at 1 January 2007 the number of applications allocated to a decision body before 1 January 2004 stood at 7,837. During 2007, 743 of these applications were communicated to a respondent Government, 328 were declared admissible and 1,247 ended with the delivery of a judgment, which represents approximately 72 % of the total number of applications in respect of which judgments were delivered.

In all 2,811 of these applications were disposed of judicially, that is, ended with a striking out decision, an inadmissibility decision or a judgment that became final. Of those applications 792 were lodged against Turkey, 308 against Russia, 281 against Poland, 278 against Romania and 171 against Ukraine.

At the end of the year there remained 5,026 applications allocated before 1 January 2004, that is, a drop of 36%. Of those applications 1,419 were lodged against Turkey, 663 against Italy, 598 against Romania, 498 against Russia and 389 against Poland.

Time elapsed since date of allocation of cases

52 % of cases allocated to a Chamber have been pending for less than two years and 17 % for between two and three years. The remaining 31 % of cases have been pending for over three years.

55 % of cases allocated to a Committee have been pending for less than one year, 32 % for more than one year and 12 % for more than two years.

Chart 1 Applications allocated to a decision body per year

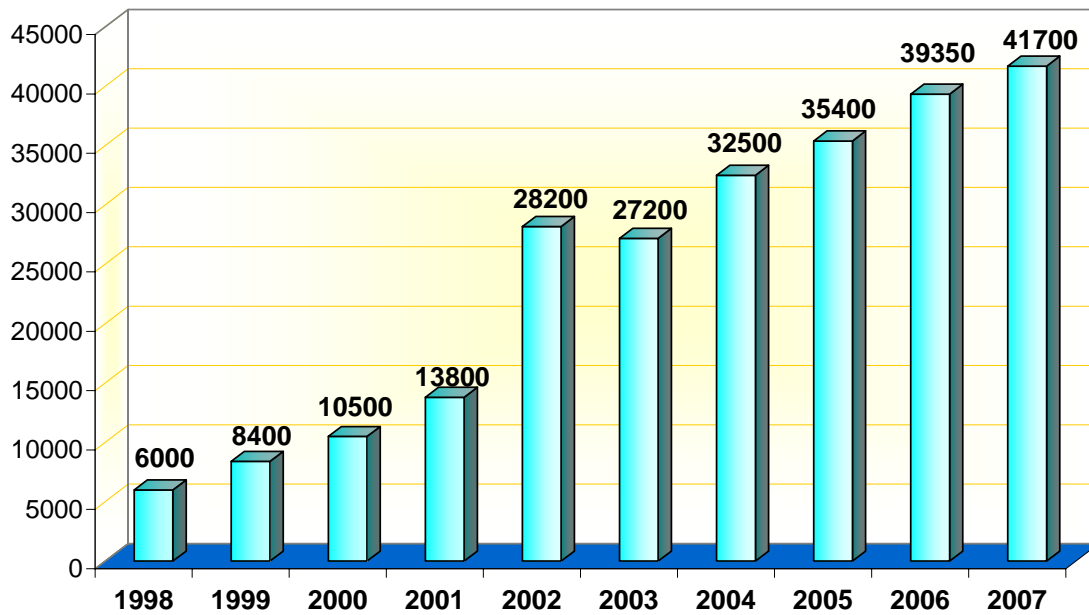
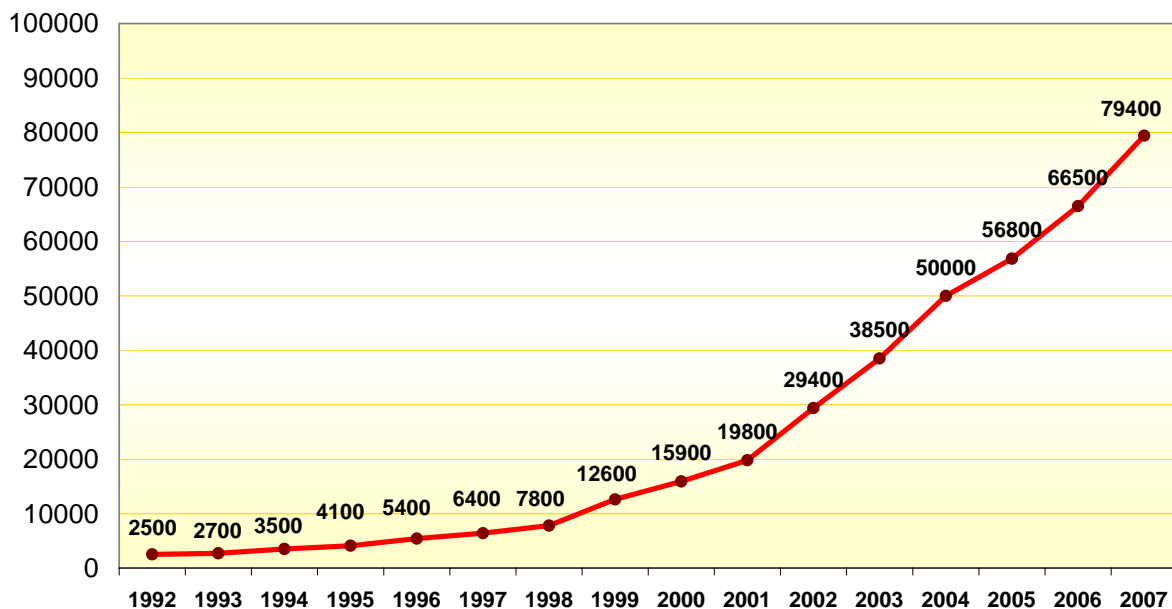


Chart 2 Applications pending before a decision body

Chart 3 High case-count States (more than 2,000 applications pending before a decision body)

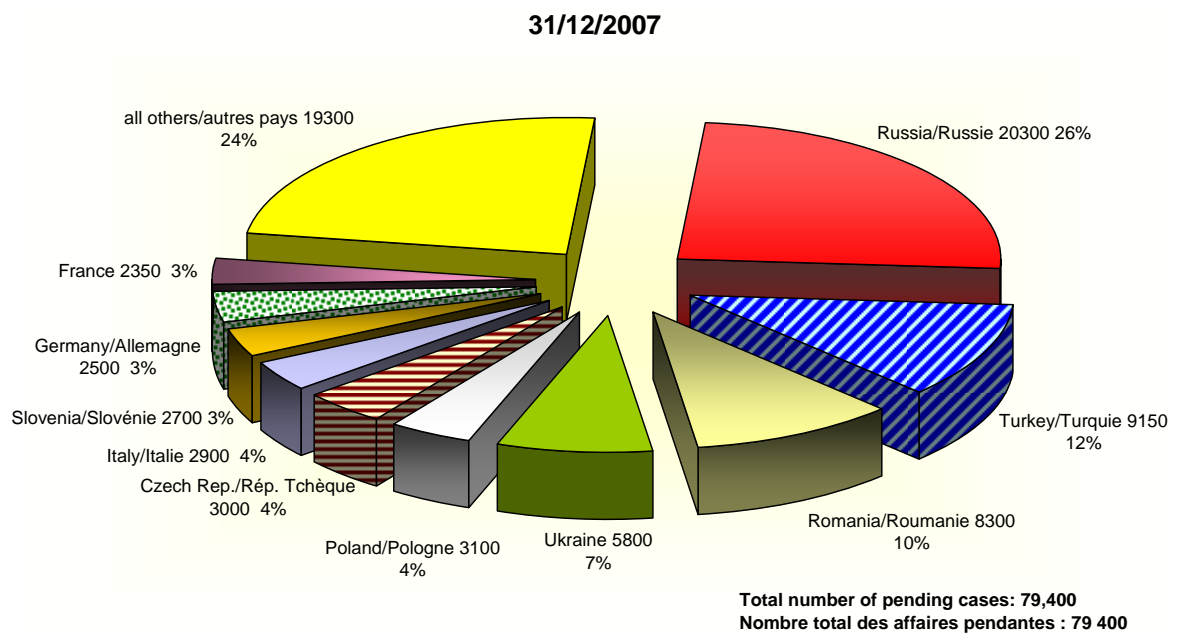
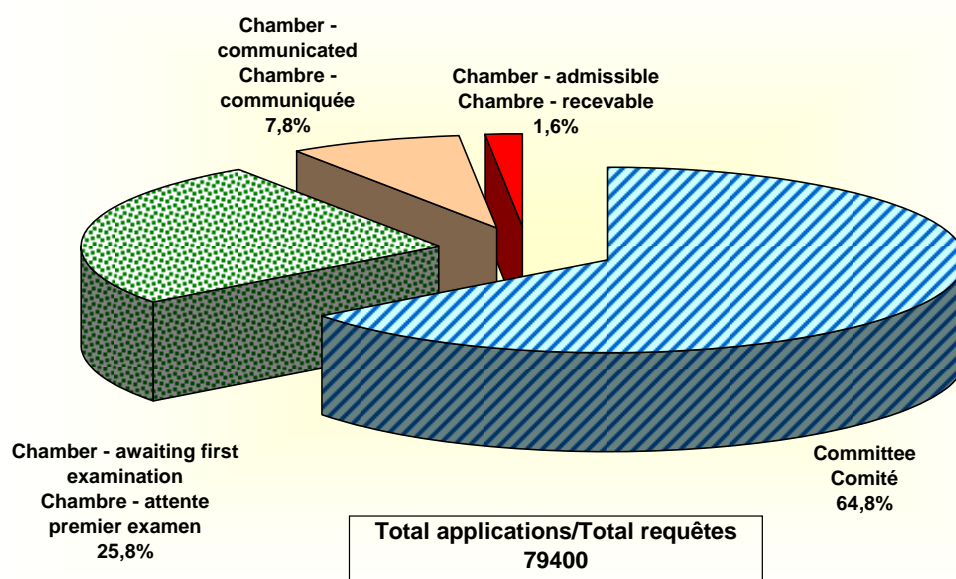


Chart 4 The Court's total caseload by stage of proceedings and decision body

Chart 5 Major procedural steps in processing applications

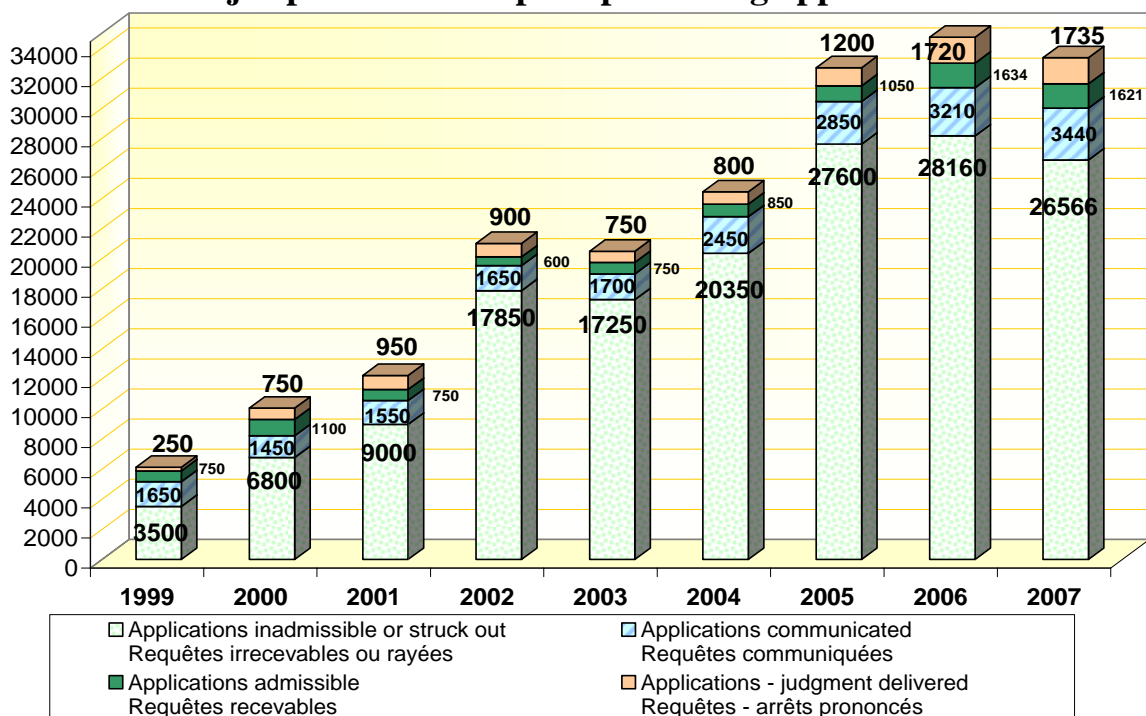
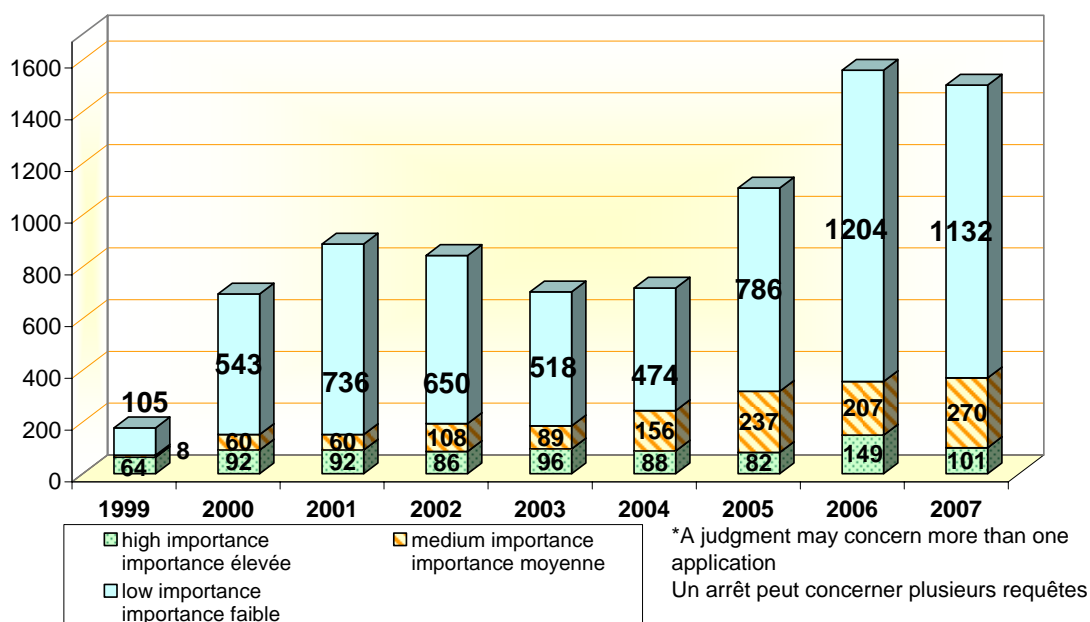


Chart 6 Judgments by level of importance³

1. High importance, judgments which the Court considers make a significant contribution to the development, clarification or modification of its case-law, either generally or in relation to a particular State.
2. Medium importance, judgments which do not make a significant contribution to the case-law but nevertheless do not merely apply existing case-law.
3. Low importance, judgments with little legal interest - those applying existing case-law, friendly settlements and striking out judgments (unless these have any particular point of interest).

Chart 7 Requests for interim measures 2005-2007⁴

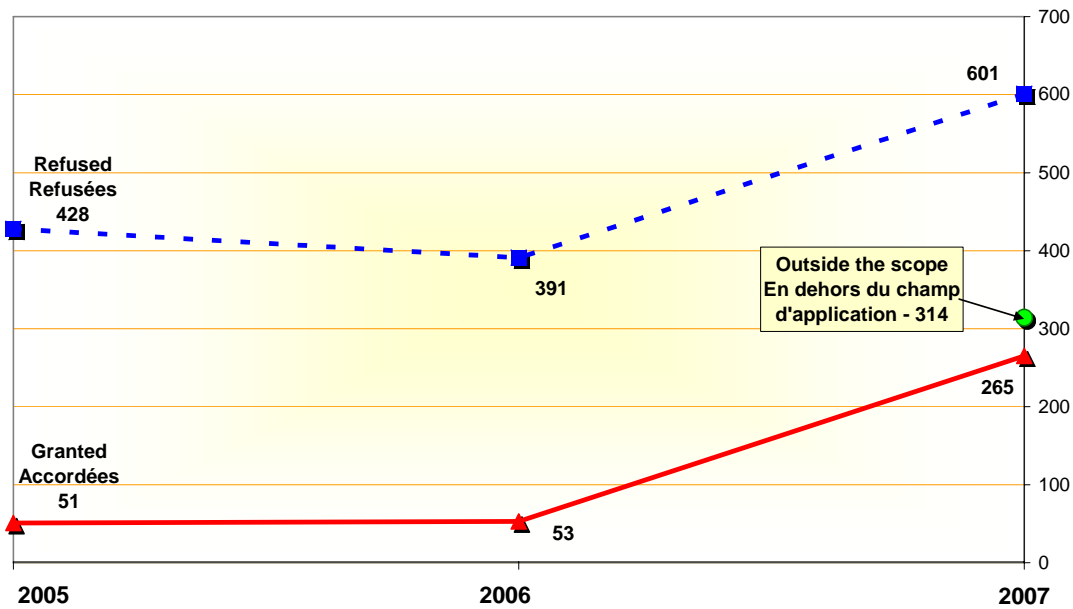
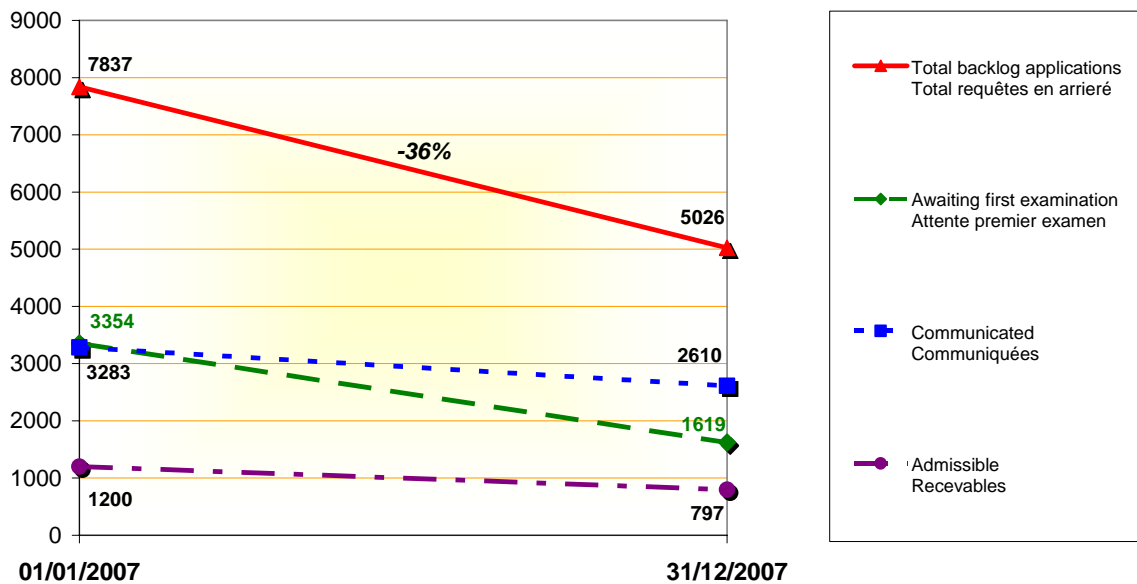


Chart 8 Applications allocated to a decision body before 1 January 2004 (backlog)

Chart 9 Time elapsed since date of allocation to a decision body– Pending Chamber cases

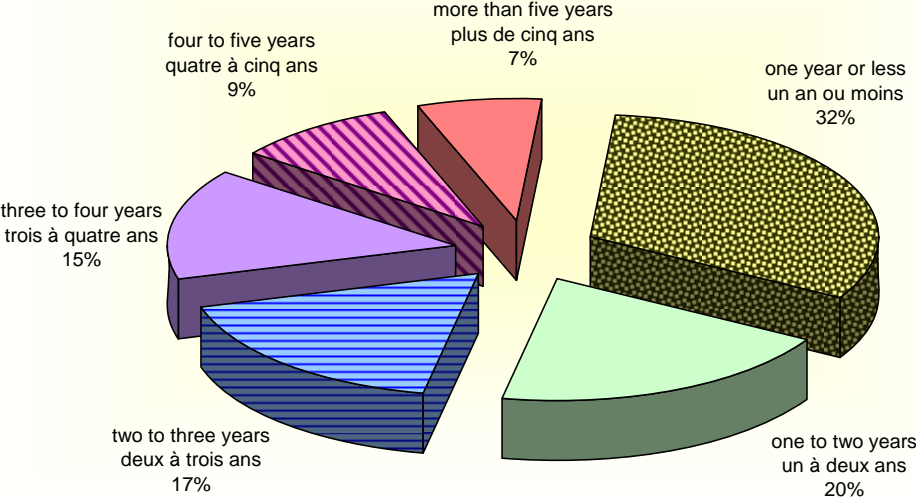


Chart 10 Time elapsed since date of allocation to a decision body – Pending Committee cases

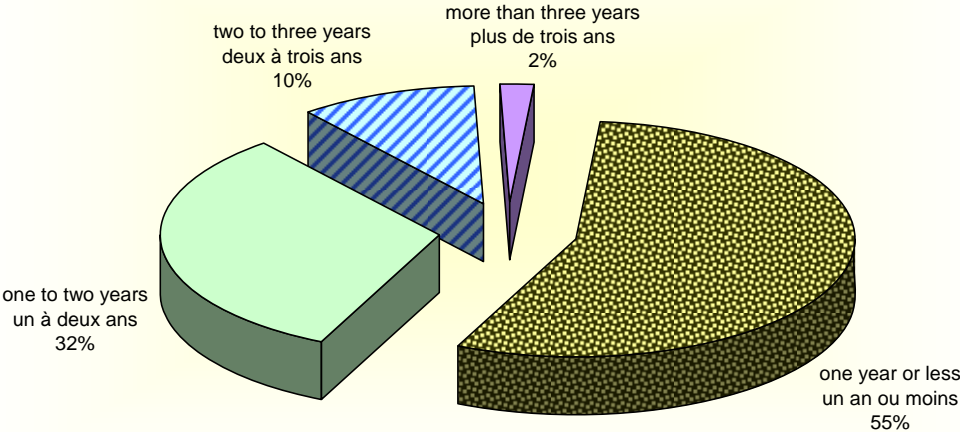
